

Free Groceries for a Year with Red Bull Sweepstakes Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

1. **No purchase necessary.** Void where prohibited by law. All federal, state and local laws apply.
2. **Eligibility:** The Free Groceries for a Year with Red Bull Sweepstakes is open to: (i) legal residents of DE, MD, PA, NY, NJ, VA, or WV; and (ii) who are 18 years of age or older. Employees and their immediate family members of Weis Markets, Inc. ("Sponsor"), Red Bull North America, Inc., and their affiliated companies and divisions are ineligible. Employees of any of the participating vendors of Weis Markets, Inc. are ineligible to qualify and win. Prizes are not transferable. No cash substitutions.  - (1) *Purchase method of entry.* Visit any participating Weis Markets location during the Sweepstakes Period and use your Weis Preferred or Gold Shoppers Club Card when you purchase a Red Bull Peach-Nectarine 12 oz. single can or a Red Bull Sugar Free Crisp Pear 12 oz. single can. The Weis Preferred or Gold Shoppers Club Card number will be recorded as an entry in this sweepstakes. An Entrant will receive one (1) entry into the Sweepstakes for each purchase of Red Bull Peach-Nectarine 12 oz. single can or Red Bull Sugar Free Crisp Pear 12 oz. single can, when he or she uses their Shoppers Club Card during the Sweepstakes Period. Handwritten postcard must contain on the reverse side; a) the name of the sweepstakes, b) the entrant's name, address, city, state and zip code, c) the entrant's phone number. Entries without this information or proper postmark will be disqualified. You may enter as often as you wish via the free method of entry.
